- I do hereby declare that I will make use and rent the Club's equipment (including but not limited to sailboats / catamarans and sails, windsurf boards and sails, paddleboards, canoes, oars, buoyancy aids, harnesses and foot or other straps) at my own risk and do hereby release and hold harmless the F.D.S.C. «Begafigo» as well as its officers, members, agents and employees, both jointly and severally from any liability or loss, injury or property damage.
- I responsibly state that I do not have any disability or health matter that could prevent my ability to rent any Club equipment.
- I do hereby acknowledge that the Club's activities might be regarded as potentially dangerous and I agree to follow all safety rules, regulations, guidelines, recommendations or precautions set out by the Club's regulations and/or governing bodies.
- I understand that the Club has no obligation of monitoring my activities and I am committed to sail within the visibility and vicinity of the Club's ashore.
- I understand that the Club has no rescue facilities and/or rescue boats. Should it be deemed necessary (life threatening incident) Rib operators and crew will attempt to recover people, giving priority to children, and not personal property. Such recovery attempts shall be reported to the official authorities and charged accordingly. I will remain solely responsible for any damage caused on the Club's equipment / property.
- I shall respect the Club's facilities, equipment and natural environment and I commit to wash and return all items to their original place, e.g. boats, water hose, trolleys, boxes, tools, ropes, anchors etc.
- In case of participating in the Club's racing activities / sessions I agree to be bound by the racing rules of sailing and by all other rules that govern the Club's events set by the Officer of the Date (OOD).
- Equipment is rent only in the presence of a Club's authorised person.

## **Personal Data Privacy Notice («Privacy Notice»)**

The Famagusta District Sailing Club «Begafigo» (hereinafter referred to as «Begafigo» or «the Club») is a duly recognised and authorised Society (club) pursuant to the Societies and Institutions and Other Related Matters Law, N. 104(I)/2017, as amended, having registration number 2677, as well as a registered club under Cyprus Sports Organisation having registration number 615 and is the Data Controller for the purposes of this Privacy Notice. The main establishment and the central administration of the Club is at Famagusta, Ayia Triada, Paralimni, 5318, Republic of Cyprus.

Should you require any further clarifications or information as to how Begafigo processes your personal data, you may contact the designated Data Protection Officer via email at [info@begafigo.com](mailto:info@begafigo.com) or by post at P.O. Box 33897, 5318, Paralimni, Famagusta, Republic of Cyprus.

Your personal data, including any special categories of personal data (where applicable) shall be processed for the purposes of you making use and rent the Club's equipment, to comply with our legal and statutory obligations, as well as for the purposes of the legitimate interests pursued by the Club.

The personal data will be processed only by authorised persons of the Club, provided that it is necessary to perform and comply with the Club's statutory and other related obligations and/or pursuant to your express consent and/or for protecting the Club's legitimate interests. Personal Data may be transferred to the Cyprus Sailing Federation and/or other governmental Authorities and on that basis Begafigo has taken all reasonable measures to ensure that the personal data are processed or disclosed as required by law.

You have the right to request access, rectification, to restrict the processing of your personal data, to object, to request erasure as well as the right to data portability. Where the data processing is taking place solely pursuant to your express consent, you have the right to withdraw such consent at any given moment. Such consent withdrawal will not affect the lawfulness of any data processing based on that ground prior to your withdrawal.

You also have a right to raise a complaint before the Cyprus' personal data supervisory authority, the Office of the Commissioner for Personal Data Protection (<http://www.dataprotection.gov.cy>).

Begafigo will retain your personal data for a period up to 7 (seven) years, depending on the legal and/or statutory and/or other obligations deriving by the law governing the operations of the Club.
